

## ScratchMaster®<sup>RF</sup> Lifetime Residential Wear and Waterproof Limited Warranty

Applies to the following ScratchMaster®<sup>RF</sup> products (592 xxx, 594 xxx)

Subject to the exclusions and limitations set out below, Next Floor® warrants that this product:

- will not wear through, where “wear through” means the complete loss of wear layer so that the printed pattern changes over a minimum of 3% of the total installation.
- will not be damaged by normal and reasonable levels of residential household moisture on the surface of the floor (this Limited Warranty applies only to ScratchMaster®<sup>RF</sup> product; no representation is made about the effect of excessive or prolonged moisture on subfloors).
- will be free from manufacturing defects.

## ScratchMaster®<sup>RF</sup> 10 Year Residential Scratch Resistance Limited Warranty

Applies to the following ScratchMaster®<sup>RF</sup> products (592 xxx, 594 xxx)

Subject to the exclusions and limitations set out below, Next Floor® warrants that this product:

- Is highly scratch resistant, defined as a test result of 10N or better when tested according to ASTM D7027 (Hoffman) Evaluation of Scratch Resistance using a Scratch Machine. If your ScratchMaster®<sup>RF</sup> floor tests below this level, Next Floor® will replace your floor subject to the remedies, conditions and limitations listed below.

## ScratchMaster®<sup>RF</sup> 10 Year Residential Pet Scratch Limited Warranty

Applies to the following ScratchMaster®<sup>RF</sup> products (592 xxx, 594 xxx)

Subject to the exclusions and limitations set out below, Next Floor® warrants that this product:

- That dogs or cats will not cause deep scratches in this floor, defined as scratches that go through the clear wear layer to the design layer. Fine scratches limited to the clear protective layer of the floor are considered normal wear and tear. If dogs or cats cause deep scratches that go through the clear wear layer to the design layer, Next Floor® will replace the affected area of your ScratchMaster®<sup>RF</sup> floor subject to the remedies, conditions and limitations listed below (maximum one replacement).

## ScratchMaster®<sup>RF</sup> 10 Year Residential Stain Resistance Limited Warranty

Applies to the following ScratchMaster®<sup>RF</sup> products (592 xxx, 594 xxx)

Subject to the exclusions and limitations set out below, Next Floor® warrants that this product:

- Will resist permanent stains from products typically found in homes, including most permanent markers, provided that the floor is properly installed and maintained in accordance with Next Floor® recommendations (visit [www.nextfloor.net](http://www.nextfloor.net) for complete Installation Instructions and Care and Maintenance Recommendations). A stain is defined as an irreversible localized color change rated less than 3.0 on the AATCC Grey Scale of Evaluating Staining (1.0 = more change; 5.0 = less change).
- This Limited Warranty excludes willful damage including burns, as well as any damage or discoloration caused by harsh substances (i.e drain cleaner, bleach, battery acid etc.) that may degrade or destroy the flooring.

## ScratchMaster®<sup>RF</sup> Limited Warranties

- Discolorations caused by asphalt type products or from inappropriate rubber mats are excluded from this Limited Warranty coverage.
- This Limited Warranty is not a cleaning contract. The consumer must perform proper cleaning and maintenance regularly and as needed. In order to make a claim under this Limited Warranty, the owner must have attempted to remove the stain within three (3) working days after occurrence of the spill.
- This Limited Warranty applies to owner occupied residential units / properties only. Residential rental units / properties are covered by the Commercial Wear Limited Warranty below.

Subject to the exclusions and limitations set out below, the following remedies are available to you if the floor fails to perform according to these Limited Warranties:

- During the first year following installation, Next Floor® will at its option (i) repair the floor to conform to this Limited Warranty or (ii) replace without charge the affected area with another floor of equal value and quality. If the floor was professionally installed by a flooring contractor, Next Floor® will also pay reasonable replacement labor costs, not to exceed two dollars (\$2.00) per square foot of product. There is no labor cost reimbursement for owner or D.I.Y. installation.
- During the second year following installation, Next Floor® will at its option (i) repair the floor to conform to this Limited Warranty or (ii) provide a credit note for 90% of the original purchase price for materials and 50% of reasonable replacements labor costs, not to exceed two dollars (\$2.00) per square foot of product, if the floor was professionally installed by a flooring contractor. There is no labor cost reimbursement for owner or D.I.Y. installation.
- After the second year following installation, Next Floor® will at its option (i) repair the floor to conform to this Limited Warranty or (ii) provide a credit note for material only (no labor costs will be covered by this Limited Warranty after the second year) based on the following schedule:
  - During the third year 80% credit
  - During the fourth year: 70% credit
  - During the fifth year: 60% credit
  - During the sixth year: 50% credit
  - During the seventh year: 40% credit
  - During the eighth year: 30% credit
  - During the ninth year: 20% credit
  - After the ninth year: 10% credit
